Mr. Tarik AMIRY - FAA president thanked Mr. Tom DIELEN – The Secretary General of World Archery for his attendance and also thanked Mr. Bruce CULL – NFAA President for his support as the main sponsor for 12<sup>th</sup> African Archery Championships, also he thanked Paige PEARCE for her coming to help and work for the success of FAA events. He also thanked Greg EASTON for his sponsorship and support.

Mr. Tarik AMIRY asked Mrs. Barbara MANNING – The Chair of Development Committee to give a word. She confirmed that every single country in Africa plays a vital role in archery development in Africa, by having a constitution and democratically elected Board with a financial structure to organize at least one archery tournament/year.

She confirmed that we need to prove to our sponsors that we are worthy to get their support, so when a Member Association asks for a development project, it must be a sustainable project and every person needs to add value to that project.

# 7. Combined report of FAA President and FAA Secretary General.

FAA Secretary General, Dr. Ahmed KOURA presented the combined report and covered the following points:

- After the election of FAA Council last December 2021, the Council came with a new vision and mission.
- We purchased a new domain name (waafrica.org) along with a new hosting.
- We purchased ZOOM subscription for online meetings Annual Fees for (2) years for our online calls and meetings (we had 6 online council meetings).
- We created a new WhatsApp Group for quick communications and sharing activities.
- We run WA Survey on WA Online Calls, good response and many participants for WA Online Calls.
- FAA Facebook Page activities, Iona PARTOTSZ FAA Media Manager.
- FAA Newsletter First issue were published on May 2022 and the second issue were published on August 2022, the 3rd issue will be published after the African Championships.
- FAA conducted Anti-Doping Webinar on 23rd March 2022 (In French and English) Dr.Dorsaf METAHNI (TUN) Chair of Medical Committee.
- FAA supported the training of National Judges (NJ) level 1, funded by EU, Archery GB and World Archery.
- Report of activity for every African Member Association.
- FAA encouraged all regions to host at least one regional archery tournament during 2022, South Africa hosted one Southern tournament and FAA supported it with the Medals.
- FAA new website, after two trials, it is still under construction.
- FAA supported the project of Para-archery Coaches training that was held in (KEN), funded by EU, Archery GB and World Archery.
- Bidding process for hosting the 12<sup>th</sup> African Archery Championships and FAA Congress, two received bids from CIV and RSA, South Africa won the bid. FAA supported the LOC financially (USD 10,000 Sponsorship + USD 5,000 Donation from FAA President).
- For the first time in Africa, Para-Archery categories and Barebow athletes are included in our 12<sup>th</sup> African Archery Championships in Pretoria 2022.

 FAA organized the Continental Judges Seminar under supervision of WA Judges Committee, all the (8) participants passed the exam and became African Continental Judges.

## 8. Financial Report.

FAA President the financial report stating that WA approved our Budget proposal for 2022 and WA transferred to FAA 50% of that budget (10,720 CHF) after deduction of WRE staging fees (1500 CHF) and Anti-Doping administration fees (780 CHF), the budget includes the expenses of the Continental Judges Seminar along with the support to the 12<sup>th</sup> African Championships.

## 12. Any other permissible business.

#### 12.1. The current situation of the African Games – Accra 2023.

FAA Secretary General - Dr. Ahmed KOURA explained the current situation of the African Games that is supposed to be held in 2023 and the conflict between the LOC & the African Union from one side and AASC/ANOCA from the other side (AASC decided to boycott the Games and the African Games also may be postponed or canceled. He also explained the FAA efforts to include Archery in the program of the African Games. FAA Secretary General also explained that archery was not included because of the National Olympic Committee of Ghana stated that there is no archery federation in Ghana and due to zero archery activity there. He finally asked the participants for their inputs to include archery and to avoid depriving Africa from the quota of (1 Mixed team) in Paris 2024 Olympic Games.

Mr. Tom Dielen – WA Secretary General explained that the Qualification system for Paris 2024 is confirmed and any change will not only require the approval of WA but also IOC. He proposed to write to all African National Olympic Committee asking them to include archery in the African Games to make a pressure and avoid losing this opportunity. But changing the qualification system now is too difficult.

Mr. Tarik AMIRY – FAA President confirmed that we will be ready to support Ghana with equipment and development activities to have archery included, although Ghana is not ready for now for hosting the African Games based on AASC and ANOCA information.

## 12.2. A Complaint from Algerian Shooting Federation (Mr. Abderrezak LAZREG).

Mr. Abderrezak LAZREG (ALG) complained about the Continental judge Khaled LAMANDE who has no right to represent in any way the Algerian Federation without a written official approval from the President or the authorized person.

WAAf President confirmed that he received many complaints about Khaled LAMANDE from different member associations that he is contacting them directly (such as: EGY, LES, MAR and SOM) and he still interferes in Africa and does not respect the right way of communication to go through WAAf office. He has no right to do so.

WAAf President asked Mr. Tom Dielen to ask Khaled to respect the rules and to not communicate with the member associations of Africa.

Mr. Tom Dielen informed the Congress that Khaled is currently an employee at World Archery for certain education programs and he will take note of the complaint, will discuss it with him and will take the appropriate action.

#### 12.3. A presentation of WA Secretary General (Mr. Tom DIELEN)

Mr. Tom DIELEN did a presentation and included the following points:

- WA Strategic Plan and the African MA's not in good standing and not active.
- African Continental Records and Continental ranking are now online on Extranet.
- Governance questionnaire: Africa improved and will get more points once the WAAf website is completed.
- The changes to WAAf Constitution need to be shared with WA before the next Congress to avoid any contradiction with WA Constitution.
- The minimum qualifying score (MQS) became 610 from women and 640 for men.
- Paralympic Qualification System: Continental quota place combined for Africa/Oceania at FQT. Para Archery development project for Africa.
- Some information need from WAAf such as: Continental preparation camp when and where preferred / Olympic qualifiers which event, place and date (even if
